		The record reveals that Horticultural Department of
		Municipal Corporation of Faridabad on complaint made by
		one of the respondents Ms. Ruchi Gupta inspected the place
		where the Eucalyptus trees in question were standing and
		made a report dated 12th March, 2015 stating that these
		trees are required to be removed to avert mis-happening in
		future. On the basis of this report, the record further reveals,
		the Municipal Corporation of Faridabad issued notice under
		Section 315 of Haryana Municipal Corporation Act, 1994 to

the applicant directing them to get the said tree removed in order to avert the nuisance and avert danger to the persons dwelling in the neighbourhood vide notice dated 1st April, 2015 at annexure R-1 to the reply of the respondent nos. 2 to 7. The record further reveals that the group of residents in locality moved a complaint made under Section 133 of CRPC before the Sub-divisional Magistrate, Faridabad seeking abetment of nuisance caused as a result of Eucalyptus trees in question. SDM disposed of this application-Case No. 149/SDM/69/2015 with the order dated 6-11-2015 directing removal of the said trees in order to abate nuisance and avert danger to the life and property of the complainants.

After having heard the parties at some length, Learned Counsel appearing on behalf of the applicant submits that she wants to withdraw the present application with the liberty to pursue the remedies against the orders passed or notices issued as regards cutting of trees in question before the competent forum/s. Permission to withdraw the present application with liberty as solicited is granted. However, this liberty may not be interpreted as any comment on the merit or demerit of the Orders/Notices which are sought to be assailed by the applicant before the Competent forum/s.

O.A. No. 460/2015 thus stands disposed of. Pending M.A. No. 09/2016, resultantly, comes to an end.
