submits that they have planted 473 trees and the same has been verified by the Forest Department.

In light of the above we allow all these four applications while impleadment of application have already been heard, we permit cutting of 43 trees but subject to the condition that actually 470 trees have been planted and they would be looked after and protected by the hospital authorities for the period of five years. Due protection, watering, manuring etc. would be provided to these trees. The Medical Superintendent would be personally responsible for the same.

Compliance of this order would be ensured by the DFO of the concerned area.

With the above directions M.A. No. 1066 and 1067 of 2016 in Original Application No. 161 of 2016 and M.A. No. 1068 and 1069 of 2016 in Original Application No. 162 of 2016 are stand disposed of.
